Dear New Resident of Barker Cypress MUD:

Welcome to **Barker Cypress MUD**. Below is a brief summary of policies, procedures, and rates. The policies, procedures, and rates are subject to change at any time

To establish service in your name, the following items must be completed and submitted to Inframark's office:

- New Service Agreement for <u>Barker Cypress MUD</u>
- Proof of Ownership:
 - Renter = Signed Lease Agreement
 - Owner = Signed Property Closing Document
- Driver's License / State / Military ID
- The district requires a \$25.00 Application Fee, \$100.00 owner's deposit/ \$200.00 tenant's deposit, and \$20.00 transfer fee prior to establishing connection. If the address is located outside of district lines, the deposit amounts will be 1 and 1/2 times the in-district deposits. If account confidentiality is requested a \$20.00 fee will appear on the first month's bill. When services are canceled for any reason, a \$20.00 final read fee is applied to the final bill. If a request is made for service to be temporarily turned off a \$20.00 fee will be added to your bill for the turn off and a \$20.00 fee to resume service.

The deposit will be applied to the final bill. If there is a credit balance on the account, a refund check will be issued, and processing time will take 6-8 weeks from the final bill date. If you are wanting same day service, all documents need to be submitted by 3:00PM CST. Inframark does not process Turn-On/Turn-Off requests Friday – Sunday or on specified holidays.

A 10% penalty will be assessed if payment is received after the due date. This amount is shown in the "AFTER DUE DATE" section on your bill.

Delinquent

If your account becomes past due, a disconnection notice will be sent to your address that may include your past due and current balance. A letter fee of \$20.00 will be assessed to your account and specified on the disconnection notice is the amount that is due to avoid termination of service. If full payment is not received as directed on the disconnection notice, your service will be disconnected. If service is disconnected, a \$30.00 disconnection fee will be added to your account and an additional \$30.00 reconnection fee along with a \$100 disconnection deposit. The full balance of your account will be required to restore service, payable by cashier's check or money order only. The payment for disconnection of service is due by 4:00PM CST Monday through Friday, to restore with same day service. If your district offers after-hour services, payments made after 4:00PM CST will be subject to after-hours fees.

NOTE: Once an account is turned off due to a non-payment: Payments made online, by QR reader, over-the-phone, or mailed, are not acceptable forms of payment to restore services.

<u>Payment Options</u>- Note: If a check payment (including payments made via alternative payment services) is returned unpaid by your bank (for any reason) a \$30.00 returned item fee will be added to your bill.
