Dear New Resident of Fort Bend Count MUD 119:

Welcome to **Fort Bend County MUD 119**. Below is a brief summary of policies, procedures, and rates. The policies, procedures, and rates are subject to change at any time.

To establish service in your name, the following items must be completed and submitted to our office:

- New Service Agreement for Fort Bend County MUD 119
- Proof of Ownership:
 - Renter = Signed Lease Agreement
 - Owner = Signed Property Closing Document
- Driver's License / State ID / Military ID / Passport
- The district requires a \$150.00 deposit for owners or a \$250.00 deposit for tenants, \$17.50 Transfer fee, and a \$5.00 confidentiality fee that will be applied to your first bill. If services are cancelled for any reason, a \$20.00 final read/ turn-off fee will appear on the next bill. After service has started, if you request for service to be temporarily tuned off (for any reason), a fee of \$20.00 will be added to your bill. Additionally, a fee of \$20.00 will be added to your bill to resume service after temporary turn off.
 - The deposit will be applied to your final bill. If there is a credit balance on the account, a refund check will be issued, and processing time will take 6-8 weeks from the final bill date.
 - If you are wanting same day service, all documents need to be submitted by 3:00PM
 CST.Inframark does not process Turn-On/Turn-Off requests Friday Sunday or on specified holidays.

NORTH FORT BEND WATER AUTHORITY FEE \$5.06 /1000

A 10% penalty will be assessed if payment is received after the due date. This amount is shown in the "AFTER DUE DATE" section on your bill.

Delinquent:

If your account becomes past due, a disconnection notice will be sent to your address that may include your past due and current balance. A letter fee of \$7.50 will be assessed to your account and specified on the disconnection notice is the amount that is due to avoid termination of service. If full payment is not received as directed on the disconnection notice, your service will be disconnected. If service is disconnected, a \$60.00 reconnection fee will be added to your account as well as a \$150.00 disconnection deposit (each time). The full balance of your account will be required to restore service, payable by cashier's check or money order only. The payment for disconnection of service is due by 4:00PM CST Monday through Friday, to restore with same day service. If your district offers after-hour services, payments made after 4:00PM CST will be subject to after-hours fees.

NOTE: Once an account is turned off due to a non-payment: Payments made online, by QR reader, over-the-phone, or mailed, are not acceptable forms of payment to restore services.
