Dear New Resident of **Harris County MUD 371**:

Welcome to **Harris County MUD 371**: Below is a brief summary of policies, procedures, and rates. The policies, procedures, and rates are subject to change at any time

To establish service in your name, the following items must be completed and submitted to Inframark's office:

- 1.) New Service Agreement for **Harris County MUD 371**
 - 2.) Proof of Ownership:
 - a. Renter = Signed Lease Agreement
 - b. Owner = Signed Property Closing Document
 - 3.) Driver's License / State ID / Military ID / Passport
 - 4.) The district requires a \$150.00 deposit prior to service start. There will be a \$35.00 application fee, \$25 Transfer fee applied to the first month's bill. A \$15.00 service agreement fee will be applied only if disconnected.
 - 5.) Once service has started, if a request is made for service to either be temporarily or permanently disconnected (for any reason) a fee of \$25.00 will be added to your bill for the turn off. Additionally, a fee of \$25.00 will be added to your bill to resume service as needed.
- The deposit will be applied to the final bill. If there is a credit balance on the account, a refund check will be issued and processing time will take 6-8 weeks from the final bill date.**
If you are wanting same day service, all documents need to be submitted by 3:00PM CST.
Inframark does not process Turn-On/Turn-Off requests Friday – Sunday or on specified holidays.

A 10% penalty will be assessed if payment is received after the due date. This amount is shown in the “AFTER DUE DATE” section on your bill.

Delinquent

If your account becomes past due, a disconnection notice will be sent to your address that may include your past due and current balance. A **\$15.00** delinquent letter fee and **\$10.00** door tag fee will be applied to your account, specified on the disconnection notice is the amount that is due to avoid termination of service. If full payment is not received as directed on the disconnection notice, your service will be disconnected. If service is disconnected, a **\$75.00 reconnection fee and \$100.00 deposit (each time)** will be added to your account. The full balance of your account will be required to restore service, payable by cashier's check or money order only. The payment for disconnection of service is due by 4:00PM CST Monday through Friday, to restore with same day service. If your district offers after-hour services, payments made after 4:00PM CST will be subject to after-hours fees.

NOTE: *Once an account is turned off due to a non-payment: Payments made online, by QR reader, over-the-phone, or mailed, are not acceptable forms of payment to restore services.*

Payment Options - Note: If a check payment is returned unpaid by your bank (for any reason), a \$35.00 returned check fee will be added to your bill.
