Dear New Resident of Harris County MUD 420:

Welcome to Harris County MUD 420. Below is a brief summary of policies, procedures, and rates. The policies, procedures, and rates are subject to change at any time

To establish service in your name, the following items must be completed and submitted to Inframark's office:

- New Service Agreement for Harris County MUD 420
- Proof of Ownership:
  - a. Renter = Signed Lease Agreement
- b. Owner = Signed Property Closing Document
- Driver's License / State ID / Military ID / Passport
- The district requires a \$75.00 deposit and \$40.00 new account fee prior to establishing services. The \$35.00 transfer fee will be applied to the first month's bill. Once service has started if a request is made for service to either be temporarily or permanently disconnected a \$22.50 fee will be added to your bill. Additionally, \$22.50 fee will be added to resume service as needed. The deposit will be applied to the final bill. If there is a credit balance on the account, a refund check will be issued and processing time will take 6-8 weeks from the final bill date. If you are wanting same day service, all documents need to be submitted by 3:00PM CST. Inframark does not process Turn-On/Turn-Off requests Friday – Sunday or on specified holidays.

### A 10% penalty will be assessed if payment is

received after the due date. This amount is shown in the "AFTER DUE DATE" section on your bill.

### Delinquent:

If your account becomes past due at the time current bills are generated, a termination notice will be sent to your address. A \$15.00 letter fee and \$10.00 door tag fee will be added to your account. Should full payment not be received as directed on the letter, your service will be disconnected. Should service be disconnected, a \$61.45 disconnection/reconnection fee, and \$75.00 disconnection deposit will be needed prior to re-establishing services. The full balance of your account will be required to restore service, payable by cashier's check or money order only. The payment for disconnection of service is due by 4:00PM CST Monday through Friday, to restore with same day service. If your district offers after-hour services, payments made after 4:00PM CST will be subject to after-hours fees.

**NOTE**: Once an account is turned off due to a non-payment: Payments made online, by QR reader, over-the-phone, or mailed, are not acceptable forms of payment to restore services.
